Chapter 10.08

OBSTRUCTIONS IN STREETS

Sections:

10.08.010 Unlawful to obstruct the passageway of streets, alleys, sidewalks or public grounds

10.08.020 Notice to remove obstruction/Penalty for failure to remove

10.08.010 Unlawful to obstruct the passageway of streets, alleys, sidewalks or public grounds. It shall be unlawful for any person to erect, place, or continue, or cause to be erected, placed, or continued, any private dwelling house, fence, buildings, or any other obstruction in or upon, or projecting into or upon any public grounds, common, street, alley, or sidewalk in said Town, nor shall it be lawful for any person to fail, neglect, or refuse to remove such house, fence, obstruction, or any building after notice from the Town Marshal so to do. (Ord. 62, S1, May 15, 1916)

10.08.020 Notice to remove obstruction/Penalty for failure to remove. Should any person or persons fail or refuse to remove any house, fence, or obstruction of any kind after five days notice by the Town authority's given by the Board of Trustees of said Town, such board shall cause the same to be removed as the expense of such person or persons, and may institute an action therefor, and judgment shall be rendered against such person or persons for the reasonable expense and costs of removal. (Ord. 62, S2, May 15, 1916)

Chapter 10.40

SPEED LIMITS

Sections:

10.40.010 Maximum speed limit on Town streets

10.40.020 Penalty for violation of Section 1.40.010

10.40.050 Maximum speed limit on State Road 45 (U.S. 231) in Chrisney

10.40.010 Maximum speed limit on Town streets. It shall hereafter be unlawful for any person, or persons driving an automobile, motorcycle, bicycles, horse or horses, and vehicles of any and all kinds within the incorporate limits of the Town of Chrisney, Spencer County, Indiana, to exceed a speed of more than twenty-five miles per hour. (Ord. 70, May 7, 1934) (Ord. 56, S1, July 1, 1912)

10.40.020 Penalty for violation of Section 1.40.010. Any person violating the provisions of Section 10.40.010 shall be fined in any sum, not less than one dollar, and not more than five dollars, to be collected in any Court of competent jurisdiction. (Ord. 70, May 7, 1934) (Ord. 56, S2, July 1, 1912)

10.40.050 Maximum speed limit on State Road 45 (U.S. 231) in Chrisney. All traffic on S.R. 45 between North Street and a point 2900 feet south thereof is 40 miles per hour. (Res. Unnumbered, Oct. 31, 1981)

Chapter 10.44

SPEED LIMITS FOR TRAINS

10.44.010 Maximum speed for trains

10.44.010 Maximum speed for trains. A person may not operate a train within the corporate limits of the Town of Chrisney at a speed in excess of ten (10) miles per hour. (Ord. 1998-2, March 2, 1998)

Chapter 10.53

WEIGHT LIMITS FOR VEHICLES ON TOWN STREETS

Sections:

10.53.010 Weight limit

10.53.020 Penalty for violation

10.53.010 Weight limit. It shall be unlawful to operate or to cause to be operated any vehicles or combination of vehicles having weight in excess of 24,000 pounds on any public street or public alley in the Town of Chrisney, Indiana excepting, however, vehicles carrying agricultural products and vehicles making deliveries within the Town of Chrisney. (Ord. 2004-7, S1, Oct. 4, 2004) (Ord. 1981-3, S1, Sept. 7, 1981)

10.53.020 Penalty for violation. Any person who violates this Ordinance shall be fined not more than five hundred dollars (\$500.00). (Ord. 1981-3, S2, Sept. 7, 1981)

Chapter 10.62

NO PARKING

Sections:

10.62.010 No parking areas designated

10.62.020 Penalty for violation

10.62.010 No parking areas designated.

- (1) It shall be unlawful to park on the east side of U.S. Hwy 231 in the Town of Chrisney along a line beginning at the point of intersection of Chestnut Street and U.S. Hwy. 231 to a point 115 feet north of said point of intersection. (Ord. 1984-2, S1, April 5, 1984)

10.62.020 Penalty for violation. Any person who violates this ordinance shall be fined not more than twenty-five dollars (\$25.00). (Ord. 1984-2, S2, April 5, 1984)

Chapter 10.72

TRACTORS WITH IRON LUGS

Sections:

10.72.010 Tractors with iron lugs on the streets prohibited

10.72.020 Penalty for violation

10.72.010 Tractors with iron lugs on the streets prohibited. It shall be unlawful for any person, persons, firm, corporation to drive or cause to be driven on the streets of the Town of Chrisney, Indiana any tractors with iron lugs on rear wheels. (Ord. unnumbered, S1, July 16, 1945)

10.72.020 Penalty for violation. Any person, persons, firm or corporation violating the provisions of this Chapter, shall be deemed guilty of a misdemeanor and shall be punished by a fine of not less than twenty-five (\$25.00) dollars nor more than one hundred (\$100.00) dollars each violation thereof. (Ord. unnumbered, S2, July 16, 1945)
