

# **TOWN OF FRENCH LICK**

## **Municipal Code**

### **A Codification of Relevant Ordinances of the Town of French Lick, Indiana.**

**ADOPTED February 7, 2002, by Ordinance No. 02-04**

**1. Ordinances codified.**

- a) The Town of French Lick, Municipal Code is hereby approved and adopted as the official Code of the Town.
- b) The French Lick Town Council determines and declares the Code to be a restatement of the original ordinances without substantive change thereto.
- c) Two copies of any material incorporated by reference into the Code are on file in the office of the Clerk-Treasurer for public inspection. (Ord. 02-04, S1, Feb. 7, 2002)

**2. Construction of Clause and Headings.**

The section headings appearing in this ordinance have been provided for convenience and reference and do not purport and shall not be deemed to define, limit or extend the scope or intent of the section to which they pertain. (Ord. 02-04, S2, Feb. 7, 2002)

**3. Repeal of Conflicting Ordinances.**

The provisions of all other ordinances in conflict with the provisions hereof are of no further force or effect and are hereby repealed. (Ord. 02-04, S3, Feb. 7, 2002)

**4. Severability Provision.**

If any part of this ordinance shall be held invalid, such part be deemed severable and the invalidity thereof shall not affect the remaining parts of this ordinance. (Ord. 02-04, S4, Feb. 7, 2002)

**5. Duration and Effective Date.**

The provisions set forth in this ordinance shall become and remain in full force and effect and until its repeal by ordinance on the date of its passage and adoption upon its signature in the manner prescribed by I.C. § 36-5-2-10(a). (Ord. 02-04, S5, Feb. 7, 2002)

## **PREFACE**

The Municipal Code of the Town of French Lick is adopted and published in order to comply with I.C. 36-1-5-1 and in order that there be a more orderly and practical means whereby interested persons may refer to those ordinances which may have a direct and immediate impact on their rights and responsibilities.

The Code will be kept current by periodic supplementation and now contains all ordinances providing for the exercise of the Town's police power through Ordinance No. 05-4, dated June 20, 2005, excluding formal parts, and are re-arranged by general subject matter for purposes of this Codification.
