Chapter 14.04

CONSTRUCTION OF STREETS

14.04.010 Town Marshal to call out able-bodied men to construct highways, streets or alleys

14.04.010 Town Marshal to call out able-bodied men to construct highways, streets or alleys. The town marshal of the Town of Gentryville, Indiana is hereby empowered and given all the rights, privileges and authority as supervisors have over their road districts under the laws of the State of Indiana and it shall be the duty of the said town marshal, to call out all able-bodied male persons under the age of fifty years, and over the age of twenty-one years, except idiots, the insane, deaf and dumb, or blind, or persons who served in the Union War or Navy during the Rebellion or the Spanish-American War, and who have an honorably discharge therefrom, within the corporate limits, who are residents of said town and state, during not less than one or more than four days of each year, and shall require such persons to work on highways, streets or alleys of said town, eight (8) hours each day: and such male persons shall furnish in such work or labor any tool or tools, mule, horse or team that the marshal may direct if the demand thereof be a reasonable one, and provided such laborer is the owner of such tool, tools, mule, horse or team, and to furnish a driver in such labor upon the highways, streets and alleys of said town: and such person or persons shall receive credit for one day for each mule or horse, and two days credit for his team, together with one days credit for such male person's services. REMOVAL OF TREES, BUSHES, RUBBISH, WEEDS FROM ALONG HIGHWAYS, STREETS AND ALLEYS

14.08.010 Removal of trees, bushes, weeds along highways, streets and alleys

14.08.020 Failure to comply

14.08.010 Removal of trees, bushes, weeds along highways, streets and alleys. Each and every owner of real estate within the corporate limits of said town are hereby ordered to cut and remove from sight all weeds, bushes, burrs, docks, and thistles and all rubbish from and along the public highways, streets and alleys adjacent to his said land within ten (10) days from the posting of this ordinance. (Ord. 6, pt. S3, July 5, 1900)

14.08.020 Failure to comply. Upon the failure of any property owner to comply with this ordinance the marshal shall be empowered to carry out the instructions of this ordinance by employing hands to cut and remove all weeds bushes, burrs, docks, and thistles and all rubbish immediately after the expiration of the ten (10) days and such cost created shall be a lien upon said real estate. (Ord. 6, pt. S3, July 5, 1900)

14.28.010 Order to build sidewalks by the Town Board. The owners of adjacent real estate and lots in said town to proposed sidewalks be and they are hereby ordered to be built and made where the sidewalks as designated and described in each ordinance. (Ord. 6, S1, July 5, 1900)

14.28.012 Specifications. Sidewalk widths and specifications are outlined in each sidewalk construction ordinance. (Ord. 6, pt. S1, July 5, 1900)

14.28.013 Removal of trees interfering with sidewalk construction. All trees that interfere with the construction of this walk shall be removed. (Ord. 6, pt. S1, July 5, 1900)

14.28.030 Failure to remove trees or construct sidewalks. Upon the failure of land owners to comply with above Sections, the town marshal shall have authority and is hereby instructed to cause the said sidewalk to be built immediately after the expiration of the specified day according to the provisions of sidewalk ordinance and upon the marshal building said sidewalk or any part thereof the costs and expenses therefor shall be declared a lien on such property and the said lien shall be assessed and collected by the Board of Trustees of said town in any court of competent jurisdiction in the manner as now provided by law for the collection of assessments for the improvements of streets, alleys, and sidewalks and upon execution against the property of such person or persons, company or corporation upon judgement the same shall be sold for costs without regard to valuation or appraisal laws of the State of Indiana.
