Chapter 4.06

PEDDLERS

Sections:

- 4.06.010 License for peddlers on foot**
- 4.06.020 License for peddlers in a vehicle**

4.06.010 License for peddlers on foot. Any person on foot and carrying merchandise of any kind excepting meat and farm products for sale in the said Town of Gentryville, Indiana, shall pay a license fee of one (1) dollar per day or fraction thereof. (Ord. 3, Feb. 3, 1900)

4.06.020 License for peddlers in a vehicle. Each person carrying merchandise of the above description in a vehicle of any kind shall pay the sum of two (2) dollars per day or fraction thereof for the privilege of selling in the said Town of Gentryville, Indiana. (Ord. 3, Feb. 3, 1990)

4.06.030 Penalty for violation. Any person who shall sell, barter or give away any of the above named articles other than the ones excepted therein without first procuring a license as above required shall upon conviction thereof be fined not less than five dollars or more than twenty dollars for each article so sold. (Ord. 3, Feb. 3, 1900)

4.06.040 Town Attorney to appear and prosecute violators. It is made the duty of the Attorney of the Town of Gentryville, Indiana to appear and prosecute each and every case against such person or persons and upon conviction thereof the said Attorney shall receive the sum of ten (10) dollars for each case so prosecuted and such shall be charged as part of the judgement and cost against such person or persons so prosecuted. Chapter 4.10

LIQUOR RETAILER'S PERMIT

4.10.010 Permit required. All businesses, stores and concerns of every kind and character within the corporate limits of the Town of Gentryville engaged in the sale to the public of spirituous, vinous, malt and other intoxicating liquors shall obtain a license to sell or retail said intoxicating liquors. (Ord. 1975-A-1, Oct. 6, 1975) (Ord. 1972-A3, April 4, 1972)

4.10.020 Issuance of permit by State of Indiana. Be it ordained, by the Board of Trustees of the town of Gentryville, Indiana, that the consent of said town be and the same is hereby given and granted unto the proper legal authorities of the State of Indiana, to issue liquor retailer's permits for the sale of alcoholic, spirituous beverages to applicants otherwise duly qualified to premises within said town, all agreeable to the provisions of section eighteen (18) of an Act of the General Assembly of the State of Indiana, entitled "AN ACT concerning alcoholic beverages, liquids and substances, and to promote temperance, repealing laws and parts of laws and declaring an emergency," approved March 11, 1935. (Ord. 1975-A-1, Oct. 6, 1975)

Chapter 4.15

CONDUCTING BUSINESS ON SUNDAYS

Sections:

- 4.15.010 Unlawful to conduct business on Sundays/Exception**
- 4.15.020 Penalty for violation**

4.15.010 Unlawful to conduct business on Sundays/Exception. It shall be unlawful for any merchant of the said Town of Gentryville, or any member of his family, or any clerk for such merchant to sell, barter or give away any dry good, notions, groceries, boots or shoes, or any article of merchandise on the day called Sunday except clothing and articles necessary for burial and funeral purposes and in all cases of necessity occasioned by sickness. (Ord. 14, S1, Oct. 4, 1901)

4.15.020 Penalty for violation. Whoever shall violate any of the provisions of the foregoing section shall be guilty of violating this town ordinance and upon conviction before the Clerk of the Town of Gentryville, Indiana, or any justice of the peace shall be fined any sum not exceeding three (\$3) dollars. (Ord., 14, S2, Oct 4, 1901)

Chapter 4.20

SHOWS, CIRCUSES, PERFORMANCES

4.20.010 License required. It shall be unlawful for any person, troupe or company to exhibit to the public, any show, public exhibition, circus or perform any slight of hand, legerdemain or any other exhibit of any character within the corporate limits of the Town of Gentryville, Indiana, without first having procured a license from the Clerk of said town, which license shall be signed by the Clerk and under the seal of said town. (Ord. 19, S1, July 4, 1902)

4.20.020 Obtaining a License/Information upon license. Upon the payment of the following fees by any person desiring to hold any public exhibition, show or other entertainment named in the above and foregoing section of this ordinance, within the corporate limits of said town, the clerk of said town shall issue to such person, troupe, or company, a license signed by the clerk and under the seal of said town which license shall stipulate the time for which said person, troupe or company is entitled to show or exhibit under said license and the amount therein paid which license shall entitle said person, troupe or company, paying such amounts, to exhibit, show or perform within the limits of said town. (Ord. 19, pt S2, July 4, 1902)

4.20.025 License fees. Fees shall be as follows: For shows, entertainments, etc., whose price of admission to the general public shall not exceed the sum of twenty cents for each adult person, Fifty cents, for each night's or day's entertainment, when the price charged by such person, troupe or company for general admission of adults exceed twenty cents for each person, One dollar for each day's or night's entertainment, provided that nothing in this ordinance shall be construed to authorize any show, entertainment or exhibition of any immoral or indecent character within the limits of said town, and provided further that this ordinance shall not apply to shows, entertainments or exhibitions given by any church or school or the citizens of said town for any religious, benevolent or educational purpose. (Ord. 19, pt. S2, July 4, 1902)

4.20.030 Penalty for violation. Whoever violates any of the provisions of this ordinance shall be fined in any sum not to exceed ten (\$10) dollars. Any upon failure of said defendant to pay or replevy said fine and costs he shall be committed to the town prison, until said fine and costs are fully paid or replevied, that when committed the town may require said prisoner to work, at seventy five cents per day upon the streets of said town until his fine and costs have been fully paid or otherwise disposed of. The Board of Trustees shall have power to remit such fines and costs of any time they deem proper. (Ord. 19, S3, July 4, 1902)
