Chapter 4.02

BUSINESS PERMIT REQUIRED

Sections:

4.02.010 Application for business permit

4.02.020 Written consent or denial

4.02.010 Application for business permit. All businesses and industry within the corporate limits of the Town of Milltown shall appear before the Common Council of the Town of Milltown at a regularly scheduled council meeting and at that time shall apply for a business permit before the Council. (Ord. 2-97, Mar. 10, 1997)

4.02.020 Written consent or denial. The Common Council of the Town of Milltown shall within thirty (30) days give written consent or denial of said permit. If consent is given, the Clerk Treasurer shall by permission of the Common Council of the Town of Milltown issue said permit. (Ord. 2-97, Mar. 10, 1997)

Chapter 4.06

TRANSIENT MERCHANTS

4.06.010 License required. That it shall be unlawful for any person, persons, firm, company or corporation to engage in the business of traveling peddler, transient salesman or itinerant vendor of goods, wares and or merchandise with the corporate limits of the Town of Milltown, Indiana, without first procuring a license so to do, providing always that the provisions of this ordinance shall not apply to residents of the Town of Milltown, Indiana. (Ord. 2004-02, S1, July 12, 2004) (Ord. 35, pt. S1, May 4, 1936) (Ord. 31, Feb. 1, 1932) (Ord. unnumbered, April 7, 1930) (Ord. 2, July 6, 1903) (Ord. 2, No date)

4.06.020 License fee. That any person, persons, firm, company or corporation desiring to obtain a license to engage in the business of traveling peddler, transient salesmen or itinerant vendor of goods, wares and or merchandise shall make application to the Town Clerk-Treasurer for license so to do and shall pay the Town Clerk the following license fees to wit:

- For one Day: \$5.00 (Five Dollars)
 - For one calendar Month: \$25.00 (Twenty Five Dollars)
 - For one calendar Year: \$50.00 (Fifty Dollars)

4.06.030 Penalty for violation. That any person violating any of the provisions of this ordinance shall forfeit and pay to the Town of Milltown, Indiana, the sum of ten dollars (Ten Dollars) for each day of the violation of the same. Fine shall be paid to the Clerk-Treasurer of the Town of Milltown, within thirty (30) calendar days of the date of said violation. If the fine is not paid within 30 days, the Town of Milltown shall have the authority to file said violation in the appropriate court for collection, including all courts cost. Chapter 4.10

CIRCUSES, SHOWS, PERFORMANCES

4.10.010 License required. It shall be unlawful for any person or persons, corporation or company within the corporate limits of said town, to exhibit under a tent, canvass or other covering, any show, circus, menagerie or exhibition of whatsoever kind, nature or description, without first securing from the Treasurer of said incorporated town of Milltown, a license so to do, for which license the said treasurer shall charge said person or persons, corporation or company, a fee. (Res. unnumbered, July 6, 1925) (Ord. 3, S1, July 6, 1903) (Ord. 2, pt. S1 & 2, No date)

4.10.020 License fee. To regulate show License in the Town of Milltown, Indiana, be it resolved by the Board of Town Trustees that on and after July 6, 1925, all shows shall pay the following rates for show license to be governed by the adult admission fee:

10¢	License Fee \$1.00 per day and night
15¢	License Fee \$1.50 per day and night
20¢	License Fee \$2.00 per day and night
25¢	License Fee \$2.50 per day and night
30¢	License Fee \$3.00 per day and night
35¢	License Fee \$3.50 per day and night
40¢	License Fee \$4.00 per day and night
45¢	License Fee \$4.50 per day and night
50¢	License Fee \$5.00 per day and night

This amendment is construed to regulate all show license indiscriminately and not effect other parts of Ordinance No. 2 as recorded and amended. (Res. unnumbered, July 6, 1925)

4.10.030 Penalty for violation. Any person or persons, corporation or company, who shall violate the provisions of this ordinance herein expressed, upon conviction thereof, shall be liable for a forfeiture to said town of Milltown, a fine, penalty, and forfeiture of not less than \$25.00, nor more than \$50.00, for each and every violation thereof, to be recovered according to law. Chapter 4.11

EXHIBITIONS, THEATRICAL PERFORMANCES, AND SHOWS NOT REACHING THE STANDARD OF CIRCUSES

4.11.010 Licensed required. It shall be unlawful for any person or persons, corporation or company, within the corporate limits of Milltown, to exhibit for a fee, pay or reward, any show, in any building, tent, or other covering, within the corporate limits of said town, said show not reaching the standard of a circus or menagerie, any exhibition of wax figures, magic lantern, tableaux, entertainments musical or otherwise, theatrical performance, or any show or entertainment of any kind whatsoever, without first securing from the treasurer of said incorporated town of Milltown, a license so to do, for which license said treasurer shall charge said person or persons, corporation or company, a fee. (Res. unnumbered, July 6, 1925) (Ord. 4, S1, July 6, 1903)

4.11.020 License fee. To regulate show license in the Town of Milltown, Indiana, be it resolved by the Board of Town Trustees that on and after July 6, 1925, all shows shall pay the following rates for show license to be governed by the adult admission fee:

- 10¢ License Fee \$1.00 per day and night
- 15¢ License Fee \$1.50 per day and night
- 20¢ License Fee \$2.00 per day and night
- 25¢ License Fee \$2.50 per day and night
- 30¢ License Fee \$3.00 per day and night
- 35¢ License Fee \$3.50 per day and night
- 40¢ License Fee \$4.00 per day and night
- 45¢ License Fee \$4.50 per day and night
- 50¢ License Fee \$5.00 per day and night

4.11.030 Penalty for violation. Any person or persons, corporation or company, who shall violate the provisions of this ordinance herein expressed, upon conviction thereof, shall be liable for a forfeiture to said town of Milltown, a fine, penalty, and forfeiture of not less than \$10.00, nor more than \$20.00, for each and every violation thereof, to be recovered according to law. LIQUOR RETAILER'S PERMIT

4.18.010 Liquor retailer's permit

4.18.010 Liquor retailer's permit. Be it ordained, by the Board of Trustees of the Town of Milltown, Indiana, that the consent of said town be and the same is hereby given and granted unto the proper legal authorities of the State of Indiana, to issue one way, two way or three way liquor retailer's permits for the sale of alcoholic, spirituous beverages to applicants otherwise duly qualified to premises within said town, all agreeable to the provisions of section eighteen (18) of an Act of the General Assembly of the State of Indiana, entitled "An Act Concerning Alcoholic beverages, liquids and substances, and to promote temperance, repealing laws and parts of laws and declaring an emergency", approved March 11, 1955. Chapter 4.20

POOL TABLES

4.20.010 Pool Tables – License fee

4.20.020 Penalty for violation

4.20.010 Pool tables – license fee. Any person who operates a pool or billiard table in the Town of Milltown, Indiana shall pay into the Treasury of the Town the sum of \$25.00 for the first and \$10.00 for the second and \$5.00 for each additional table as a License Fee for the period of one year. (Ord. 33, Jan. 1936) (Ord. 17, S1, Nov. 20, 1911)

4.20.020 Penalty for violation. Any person violating the provisions of Sec. 4.20.010 of this Chapter shall forfeit and pay to the town of Milltown, Indiana, not more than two-hundred dollars nor less than one-hundred dollars, and each day shall constitute a separate offense.
