**15.01.010 Planning and Zoning.** The Common Council of the City of Petersburg, Pike County, Indiana ("City") now deems it to be in the best interest of the City and its citizens to exercise planning and zoning powers in the City. (Ord. 1991-1, S1, Jan. 22, 1991)

**15.01.020 Establishment of Plan Commission - Members.** The Common Council hereby establishes the Petersburg Plan Commission ("Commission"). The Commission consists of seven members, four of whom shall be citizens members, appointed by the Mayor as the municipal executive, and three of whom must be elected or appointed municipal officials or employees of the City appointed by the Council. (Ord. 1991-1, S2, Jan. 22, 1991)

**15.01.030 Effective Date.** This Ordinance shall become effective from and after the date of its passage, January 22, 1991. (Ord. 1991-1, S3, Jan. 22, 1991)
