# Introduction

The town of Grandview, Indiana is located on the southern edge of Indiana between Tell City and Evansville. A group of settlers camped along Blackford Creek directly across the Ohio River in Kentucky as early as 1800 waiting for a treaty to be signed between the Delaware Indians and the United States Government. The settlers crossed the river to Grandview when the treaty was signed in 1804. The town of Grandview was settled in 1807, laid out in September of 1851 and declared incorporated in 1872. Grandview was named for it's "grand view" of the Ohio River.

There are three parks that are owned, managed and maintained by the Town of Grandview—Grandview City Park, Old Mill Park and Schroeder Park. The Grandview Parks and Recreation Board was disbanded on December 16th, 2019. At the same time, the Grandview Town Council was established under Indiana Code as a Park Authority for the town.

This Master Park Plan is the first update for the Town of Grandview since 1990. The planning area and main consumer base for this Master Plan is the parks and park users in the incorporated town limits of Grandview. Input was gathered from residents and non-residents from surrounding communities that partake in the recreational amenities offered by the Town of Grandview.

We believe that this renewed focus will not only improve our parks and recreation, but also enrich the beauty and livability of Grandview. By recognizing the value of our green spaces and recreation system, we are helping to safeguard them—not just today, but for many years to come.

The action plan developed for this Master Plan will improve the residents enjoyment of our parks and recreation amenities today and safeguard their long-term sustainability for future generations.



#### **Budget**

The Grandview Park system is funded through a line item in the Grandview town budget. Repairs to buildings and utilities are funded through the general fund.

The Park Authority realizes there is a limit to our budget and resources, and that affects on our ability to meet all of the public demand for amenities and services. The Park Authority recently instituted a \$5 boat launch fee and a fee for softball tournaments to help with the budget. They also identified needs to the softball field to make it more of a hotspot for softball tournaments and placed them on the action item list.



# **Goals and Objectives**

#### Goals of the Park Authority

The Grandview Park Authority seeks to:

- Provide quality and accessible park and recreation facilities for all age groups, abilities and economic levels.
- Maintain, preserve, protect, improve and enhance the Grandview parks, natural resources and recreational opportunities for current and future generations.
- To connect people to green spaces to provide places for gathering, celebrating, contemplating and engaging in activities that promote health, well-being, community and the environment.
- Improve the visual appearance and usability of existing park facilities to make them more appealing to the public to assure continued optimum use.
- To enhance the overall quality of life for residents through recreation.
- Expand physical access to the Ohio River in a manner that is visually appealing, available to everyone and sensitive to ecological function.
- Inform the general public about outdoor recreation needs and opportunities of Grandview, and work to obtain as much assistance as possible from local community groups.

#### Goals of the Grandview Master Park Plan

The Grandview Park Authority seeks to do the following with this Master Plan update:

- To perform an inventory and analysis to guide future development of the park system.
- To provide a roadmap to maximize access to high quality parks and recreation experiences that connect people with each other and with nature.
- Plan and develop parks within a reasonable walking distance of all residents.
- Plan and program parks and facilities for all ages, abilities and economic levels.


# **Features of the Community**



The Town of Grandview is located in Southern Indiana along the Ohio River at river mile marker 742. It is part of Spencer County and located in Hammond township. Grandview is 37 miles from Evansville, Indiana, 16 miles from Owensboro, Kentucky and 87.5 miles from Louisville, Kentucky. Indiana State Road 66 runs through the town east to west and was designated a scenic highway in 1989.

The Town of Grandview has a total area of .96 square miles. Although the towns parks are well distributed across neighborhoods, connecting to and from the recreation areas can be a challenge. The ballfields were busy with games all during the warmer months before the park system began charging fees for use to help cover upkeep costs. The ballfields drastically decreased after the fee was instituted. The park authority has been inactive in



The median household income for 2019 was \$38,490 which is up from \$35,417 in 2000. Workers in Grandview commute an average of 26 miles.


The climate in Grandview is fairly mild. Temperatures exceeds 90° for several days each summer and drops below zero for several days in winter. Nevertheless, the temperature on most days is ideal.

Rainfall is generally adequate for crops and averages 50 inches per year. The closeness to the river brings high water and flooding as snow melts in the northeast and in the spring. Many of the residential and park areas are susceptible to flooding. There is cleanup that takes place especially at the boat ramp area after each flood.



the past several years but is now actively seeking ways to increase traffic at the parks like upgrading the ballfields and safety so that they will be more attractive to future ball tournaments.

> The population (according to the US Census data) of the Town of Grandview was at its height in the year 1900 at 822. Most recently, the 2010 population was 749 and the 2020 population was 711. In 2010 there were 288 households and 199 families living in Grandview. These numbers increased slightly from the 2000 census data at 266 households and 194 families. Both census data show that 36% of households had children under the age of 18 living with them. The bulk of the population—50.9% - is of working age 25-64. The population of Grandview is also 90.3% white. The trends listed in this paragraph duplicate the regional patterns of rural areas.



The topography of Grandview is generally level to gently sloping, but mostly flat with an average elevation of 394 feet above sea level. The soil classification for Grandview lies in the Ginat Series which slow run-off adds to the issue with soil moisture.

The natural tree canopy of the town has been varied through the years. The remaining trees are mostly mixed hardwood shade trees with a variety of volunteer and structured plantings throughout the town. There are no noticeable pests in the trees or environment of Grandview except for mosquitos as mentioned by several survey responders. The Park Authority stated that no vegetation or wildlife issues exist in the town or parks.

The Town of Grandview was awarded an Indiana Waters Grant for \$248,300 in 1991 to install a boat ramp located on the Ohio River. The town was also awarded a \$66,450 grant to install a floating dock at the boat ramp with a ramp from the parking lot.

There is a disc golf course located in the Grandview City Park is a popular attraction that draws regular participants from not only Grandview, but Owensboro (KY) and Evansville. The course is also listed on the website discgolfscene.com. The town works closely with the Army Corp of Engineers for maintenance and updates to the park along the river.



Students in Grandview travel to Rockport, Indiana six miles west to school. Grandview has

a low-income housing unit. The school system is the only dedicated childcare for families. During the summer months, grandparents or one non-working parent perform childcare duties. According to the survey answers, the grandparents use the parks a lot during the summer months and after school.

The town operates its own water and wastewater systems and have recently upgraded both. A master utility study is currently underway to identify any additional upgrades needed. They recently sold their natural gas system to Ohio Valley Gas.

The average age of houses in the Town of Grandview along the State Road 66/Main Street (also the business district) three block corridor is 1927. The oldest house is a Queen Anne built in 1851. The average age of commercial buildings in the same corridor is 1920. Some of these buildings have been restored and well maintained and others are in disrepair. There is a marker stating Abraham Lincoln travelled Main Street hauling goods to and from the Ohio River.

As the lifestyles of residents and park visitors continue to change, the park system need to also evolve. The Town of Grandview needs better lighting and additional/renovated sidewalks for better and safer access to and between parks. The direction set in this plan was guided by the insights gained through the public participation and research of demographic shifts, recreation trends and health trends. The Park Authority feels that better and safer access to and between the park areas will help with this and increase usage.

Nationally there is a growing concern that people, especially children are losing their connection to nature. Some cite technology as directly competing for their leisure time, while others fear that technology is replacing hands-on learning with indirect learning. Forging a connection between people and natural areas will help ensure the long-term stewardship of the park system and build valuable life lessons.

Events held in Grandview are: the Grandview Fall Festival by the Grandview Civic Association; Sizzlin Summerfest by the Spencer County Fair; and Octoberfest by the Spencer County Fair. There are also softball, horseshoe and disc golf tournaments held in Grandview.

# **Park Department - information and inventory**

The Grandview Park Authority is responsible for three parks—City Park, Old Mill Park and Schroeder Park. Additional Spencer County parks and recreation areas are listed by federal, state, local, schools and private.

Grandview City Park 2nd and Walnut Streets Grandview, Indiana

City Park was established by the Town of Grandview. The 19-acre park has a variety of activities that include softball field, basketball court, playground, picnic area, disc golf course, horseshoe pits and a 65-foot zipline. The park also has two shelter houses that offer shade and seating. The city park is a great place to picnic, relax and enjoy recreational activities. The park is mostly flat and lightly wooded.





Old Mill Park 5th Street Grandview, Indiana

Old Mill Park was established by the Grandview Garden Club on town-owned property The one-half acre park has a variety of activities that include picnic area and playground. The park is mostly flat and lightly wooded.

**Schroeder Park** State Road 66 Grandview, Indiana

Schroeder Park is owned by the Town of Grandview. The ten acre park is owned by the Town of Grandview and has a variety of activities that include fishing, playground and picnic area. The park is mostly flat and lightly wooded.



#### **Federal**

Lincoln Boyhood National Memorial PO Box 1816 Lincoln City, IN 47552 812-937-4541 / 812-937-9929

The Lincoln Boyhood National Memorial was established in 1962 and is composed of a Memorial Building and Visitor Center and the Lincoln Living Historical Farm. Stone murals flanking the Visitor Center tell the pictorial story of Lincoln's life. Inside is a small museum, interpretative motion picture, Nancy Hanks Lincoln Hall and Abraham Lincoln Hall.

The visitor center is open daily 8:00 am—5:00 pm. The historical farm is open mid April through September.

#### State

#### **Lincoln State Park**

Lincoln State Park is the only state recreation area in Spencer County and was established in 1932. The 1,747 acre park adjoins the Lincoln Boyhood National Memorial. There is a 10-mile hiking trail, fire tower, the church Abraham Lincoln attended and Sarah Lincoln's Woods Nature Preserve. Seasonal naturalists provide programs from Memorial Day until Labor Day. A 58-acre lake with a swimming beach and bathhouse, fishing, boat rentals, paddle boats, canoes, playground, tennis court, shelter houses and numerous picnic sites available. There are cabins, primitive campsites and RV sites available for rent.

#### **Lincoln Amphitheatre**

Lincoln Amphitheatre was established in 1987 and is part of Lincoln State Park. The 1500+ seat covered amphitheatre features a musical story of Abraham Lincoln's life, and concerts including rock and roll, country, theatrical and classical.

#### **Colonel William Jones State Historic Site**

The Colonel William Jones State Historic Site is listed on the National Register of Historic Places and is located on Boone Street, one mile west of US 231 in Gentryville. The 1834 Federal design home of merchant employer of Abraham Lincoln features guided tours, themed talks and a gift shop called the Jonesboro Merchantile.

#### Local

#### **Huffman Covered Bridge**

Huffman covered bridge is located on the eastern county line spanning the Anderson River between Spencer and Perry counties. The bridge was constructed in 1965 and listed on the National Register of Historic Places in 1998. The bridge is now a footbridge only. A new bridge was constructed north of the Huffman Bridge for automobiles. Thomas Lincoln brought his young son Abraham to Huffman to mill his corn. The single span yellow poplar bridge is covered with a 20 panel Burr Arch-Truss bridge timber frame. The overall span is 148 feet long, with a ten-foot overhang on each end.

#### **Private**

#### Holiday World & Splashin' Safari

Holiday World is the nation's first theme park that was known as Santa Claus Land (which opened in 1954) until 1984. Splashin' Safari water park opened in 1993. The park is divided into four sections: Christmas, Halloween, Thanksgiving and Forth of July. It includes three wooden roller coasters, multiple waterslides, wave pools, amusement park rides and of course a visit with Santa.

#### Lake Rudolph Campground and RV Resort

Lake Rudolph campground is located on SR 245 adjacent to Holiday World. Lake Rudolph is a 70-acre resort that opened in 1985, originally as a private resort, but is now open to the public. The resort features more than 150 RV/tent sites. The RV sites have access to water, electric, sewer, picnic tables, grills, showers, toilets and laundry equipment. Campers may use their own RV or rent one owned by the resort. There are also cabins available for rent, two swimming pools, miniature golf, fishing lake, paddle boats, playgrounds, basketball, shelter house, horseshoes, country store and bath house.

#### St. Meinrad Archabbey

St. Meinrad Archabbey was founded in 1854 and is located on SR 62 in St. Meinrad. The church was completed in 1907 and is operated by Benedictine monks. The Archabbey is located on a high hill overlooking a

small community and has twin spires and eye-catching towers. Self-guided brochures allow visitors to wander through the well-kept grounds and serene rock garden.

#### **Monte Casino Chapel**

The Monte Casino Chapel is located one mile north of the Archabbey and was dedicated in 1870. The grounds offer a panoramic view of the Anderson valley and the chapel and surrounding picnic area are open year-round during daylight hours.

#### **Spencer County Memorial Forest**

The Spencer County Memorial Forest is located on CR 1550 off SR 545 in Fulda. It offers spectacular foliage and features a towering World War II Veterans Memorial. There are shelter houses available for picnics and events.

#### **Christmas Lake Golf Course**

Christmas Lake Golf Course is located on SR 245 south in the town of Santa Claus. This 18-hole championship course has been acclaimed by Golf Digest as one of the top 100 courses in America. It was designed in 1967 by renowned architect Edmund Ault. The golf course also has a driving range, pro shop, grill, banquet facilities, restaurant and lounge.

#### **Lakewood Country Club**

Lakewood Country Club is a challenging nine-hole course located on SR 45 south of Rockport. It is open to the public on weekdays and after 2:00 pm on weekends.

#### **Chrisney Golf Course**

Chrisney Golf Course is a community civic association nine-hole course operated and maintained by volunteers. No carts are available, but there is a ramp where you can unload your own.

#### **Lincoln Pioneer Village**

Lincoln Pioneer Village is located in Rockport, next to the City Park. It commemorates the life and times of Abraham Lincoln and his family. The village has a museum, artifacts and a collection of 13 pioneer cabins that stand tribute to the survival of forefathers in the southwest Indiana wilderness. The village was built in 1935-36 by Works Progress Administration (WPA) a Franklin Delano Roosevelt depression-era program. The village was designed by George Hoening. The log cabins are replicas of the John Pitcher Law Office, Sarah Lincoln Grisby home, James Gentry (merchant and farmer) cabin and Josiah Crawford home (employer and neighbor of Abraham and Sarah Lincoln). The village was listed on the Register of Historic Places in 1998 and is operated by the "Friends of the Lincoln Pioneer Village and Museum", a non-profit organization.

#### Lincoln Landing/Rockport Bluff

The Lincoln Landing site or Rockport Bluff is the historic site where Abraham Lincoln launched a flatboat to transport produce to New Orleans for a local merchant in 1828. Abraham Lincoln saw slavery for the first time during this trip to New Orleans. Lincoln Landing is on River Road at the east end of Main Street in Rockport, Indiana. The area includes a beautiful rock-sculpted bluff and park for picnics and viewing the river.

#### **Lincoln Ferry Park**

Lincoln Ferry Park overlooks the Ohio River on SR 66 just west of the Spencer County line near Troy, Indiana. A shelter house and shaded picnic tables enhance one's travel along State Road 66 on the designated Ohio River Scenic Route. This historic spot is where the Lincoln family was ferried across the Ohio River into Indiana in 1816.

#### Fischer's Lake

Fischer's Lake is a private campground located 2.5 miles east of Newtonville on SR 70 and consists of approximately 70 acres. It features campsites with electricity, water, picnic tables, flush toilets and showers. Grills, two large shelter houses and an enclosed shelter house are also available. The 14-acre man-made spring fed lake offers swimming, sand beach, fishing and boating. Boats can be rented and a concession stand and dance pavilion are located near the beach..

#### Heritage Hills Campground

Heritage Hills Campground is located near US 231 south of Gentryville. The campground is open year-round and has campsites with electricity, playground equipment and picnic tables. A well stocked 5-acre fishing lake and 70 acres of rolling wooded terrain add to the beauty of this secluded campground.

#### **Honey Creek Farm**

Honey Creek Farm opened in October of 1998 and is located just off US 231 north of the American Electric Power (AEP) plant. The farm has approximately 3,200 acres and is owned by AEP and is used by employees and residents of the communities surrounding the plant. The farm includes a barn with a lean-to that is used as a community center. The barn has a loft that was transformed into the Land of Oz, complete with yellow brick road for children's activities. The center is furnished with picnic tables made from recycled products. There are also some walking trails on the property with observation stations for wildlife viewing and rest areas with benches. The development of this property is primarily done by volunteers.

# Accessibility

The Grandview Park Authority is committed to making our facilities and services available to anyone, regardless of resident status, physical or mental ability. As facilities are renovated or replaced, they are done according to ADA standards.

The Town of Grandview ADA coordinator is Keith Nix, Town Manager. Mr. Nix can be reached at 812-649-2573. The Spencer County ADA and Title 6 Coordinator is Kay Erwin. The Town of Grandview town hall is ADA accessible. If meetings are going to have a large attendance, sometimes the fire station or civic center is used. Both of these buildings are also ADA accessible. The Town asks to be made aware of additional accessibility requirements in public notices for meetings.

The Town of Grandview created an ADA Plan for all town owned properties in May of 2020. The ADA committee meets annually for a planning meeting and will update the plan every two years.

#### **Grandview City Park**

City Park has two shelter houses that that were made ADA accessible with sidewalks installed at the correct grade in 2021.

The softball field is not currently ADA accessible.

The basketball court has a paved parking lot, but a grass approach surrounding the court.

The playground and Goose Hollow Disc Golf Course have a gravel parking area and grass approach.

#### **Old Mill Park**

Old Mill Park includes a picnic area with a shelter that is surrounded by grass.

The playground has an ADA swing, but the approach is grass and the underlayment is mulch.

#### Schroeder Park

Schroeder Park has a fishing area with a dock that is ADA accessible.

The playground is grass and mulch that is not ADA accessible.

The picnic area has a shelter that is surrounded by grass.




# **Public Participation**

The Grandview Park Authority launched an online survey that gave all residents, park users and local elected officials an opportunity to share their thoughts about the park and recreation wants and needs. #### **PARKS PLAN**

Burrows reported that the town's Five-Year Parks Plan is currently under development by Indiana Region 15. Surveys have been sent out to residents seeking input the needs of the town's parks, and could have a significant impact. A parks plan is necessary for many state grants, and could open up the town to more funding and resources. Councilman Jordan Sheets urged the council to review whether there were other plans the town should have on the books, or updated, to ensure other grant funding isn't being left on the table.

An electronic survey is available to the residents in the Town of Grandview and to other users of the park at https://www.surveymonkey.com/r/grandviewparks. Answers to the survey will remain anonymous and provide valuable input that the Parks and Recreation Board will consider.

The updated plan will be used as a guide for the Town of Grandview to improve upon current recreational opportunities and provide new ideas residents may bring to light.

#### **Survey Findings**

The survey had 23 respondents of which 70% were residents of Grandview. Even though 23 responders does not sound like a lot, it is more than has participated in past surveys for things like water issues. In addition to the online survey, residents also made phone calls to the town hall, Indiana 15 Regional Planning Commission and the Park Authority members.

Seventy-four percent of respondents to the survey had participated in activities at a Grandview Park and 26% of these had visited more than 10 times in the past 90 days.

The largest activity engaged in at a Grandview Park was the playgrounds. When asked to rate the importance of various park system amenities, respondents also ranked playgrounds highest. Related amenities such as the zipline, picnic areas and disc golf also receive high rankings.

Sixty-five percent of respondents had visited a park outside Grandview in the last three years. The activity most participated in outside of Grandview was playgrounds, splash parks, disc golf and picnics.

When asked what the Park Authority could do to help enhance participation in the park system, walking/biking trails were the highest requested. Specifically requested was a trail wide enough for strollers. Also mentioned is a problem with mosquitos, upgrade/repair on grills needed, portable bathrooms needed, trash cans needed, better cleaning of floors of shelters, lights/fencing upgrade at the softball field and more events (craft/vendor fairs). This indicates additional focus is needed for these areas.

Within the natural environment, residents indicate they enjoy walking, biking, viewing nature, and picnicking. Residents indicate they want more focus on keeping parks clean.

Afternoons and weekends were reported as the best time for park programs at 30%, followed closely by evenings at 26%.

Though 68% of survey respondents report no issues finding out about recreational opportunities at Grandview Parks a Facebook page and joining all area disc golf club groups on Facebook were suggested as additional means of promotion.


Overall, residents feel the Park Authority is doing a good job of providing for their household's park and recreation needs. The overall quality of park facilities were ranked 4.26 out of 5 stars.

After careful listening and analysis of all comments received, the following top community needs emerged.

- Boat dock at the Grandview boat launch
- Parking lot at the Grandview boat launch
- Safely connecting the parks and park access
- More ADA access
- Walking/biking trails
- Parking at City Park
- Upgrade existing playground equipment and add additional options
- Lights and fencing at the softball field



#### Q1 Do you live in Grandview?





#### Q2 What are the ages in your household? (choose all that apply)









# Q9 What are the most convenient program times for you and others in your household?









## Grandview council holds two public hearings

GRANDVIEW - Two public hearings on important town plans were held at the start of the Grandview town council meeting on Monday, March 21.

The first public hearing was in regards to the Grandview five year Park and Recreation Master Plan. The second hearing was discussing the towns application to the Indiana Office of Community and Rural Affairs (OCRA) for a grant to complete a master utility study.

Cheri Taylor, a financial administrator with Indiana 15 Regional Planning Commission presented on the park plan. Having a plan that is approved by Indiana Department of Natural Resources will make Grandview eligible for their

An online survey was taken and other feedback was gathered to determine any projects that the community would like to see completed which were then put together in the work plan that spans over a five year

In January, they sent a draft of the plant to Indiana DNR and they received comments back. The work plan itself has not changed but they did add further narrative on information pertaining to Grandview.

Taylor explained she was at the meeting to gather any comments from the public or additional items that would need to be added before a final draft of the plan was submitted. The plan is due to Indiana DNR by April 15, and Taylor plans to submit it by the end of March.

Taylor had the council flip to the page in the work plan titled Priorities and Action Schedule. These pages detail different action plans the town would like to address from 2022 to 2026, the cost of the project and potential funding sources.

In 2022, one action for the town is to add lights and fencing at the softball field at the Grandview City Park with an estimated cost of \$100,000 with local funding. The responses to the survey were included in the plan as well.

Nathan Held, Senior Project Administrator with Indiana 15 Regional Planning Commission presented during the second public hearing. The town is requesting for \$90,000, which is the maximum for a master utility study (water, wastewater, and stormwater). Grandview will be putting forth a match of \$10,000. The application is due on April 14.

The main purpose for the public hearing was to gather any public comments regarding the study. Held also stressed the importance of gathering public input for the grant application. Letters of support are needed from the public to include with the application, as well as photo examples of any issues or complaints.

### Grandview Town Council moving forward on updated park plan, utilities planning grant

GRANDVIEW - The Grandview Town Council held two public hearings immediately before their regular meeting March 21. Both of these hearings dovetailed neatly into the primary business of the evening. Namely, forward progress on submitting a five-year park plan as well as the submission of an application for a master utility planning grant through the Indiana Office of Rural and Community Affairs.

While the park plan and planning grant are distinct initiatives, focusing on the needs of the town's public spaces and its water and wastewater systems respectively, both could be the key to unlocking state and federal funding sources. An up-to-date park plan is necessary to qualify, or at least earn primary consideration, for grants from the Indiana Department of Natural Resources. Furthermore, if the town secures a planning grant to assess the needs o its water and wastewater infrastructure, that information would be invaluable when it comes to applying for state and federal grant and loan programs in the com-ing months and years. With the American Rescue Plan funding yet to be disbursed and more resources from the 2021 infrastructure bill coming down the pipe, it would naturally be ideal for Grandview to be in a position to apply for any and all opportunities that arise.

Cheri Taylor of Indiana 15 Regional Planning Commission was present at the public hearing for the park plan to offer some details on the latest draft, which should closely resemble the final product. However, she noted there is still time to make adjustments if town officials should be made aware of any other potential park needs. Taylor hopes to have a final draft submitted by the end of the month, but she also emphasized the plan could be amended later over the next five years.


"This is not set in stone," she said. "You can always add to it."

The park plan, as currently presented, lays out a detailed slate of priorities for the next five years. These projects are divided by years of projected implementation, recurring

annual commitments, probable funding sources, etc.

For 2022, the plan calls for new lights and fencing at the softball field in Grandview City Park at a projected cost of \$100,000 from local funds. New benches may also be added to the disc golf course, with a projected cost of \$9,000 provided by civic groups and donations. The addition of wireless internet at all public parks in the town is also in the offing for this year, though this is contingent on the completion of Perry-Spencer Communications' planned build out of a fiber network through the town in the fall. Finally, the plan calls to begin the process of locating funding for a new boat dock in Schroeder Park

along the river.

By 2023 or 2024, the plan calls for moving forward on acquiring and installing the new dock at the boat launch, as well as maintenance plans for it. Those costs would be substantial, totaling nearly \$1 million as of now, but DNR grant programs could accommodate the project. Other planned improvements along

this time frame include the installation of a rock climbing wall at Grandview City Park, as well as expanded rentals at the softball field. The park plan also expects the town to seek out grant funding for new trails, sidewalks or other walkability upgrades at around that time, with those projects likely to dominate 2025.

By 2026, the main priorities will include additional parking at Grandview City Park and new trails or other walkways at Schroeder Park and the boat launch. Several action items are also likely to dominate throughout the entire five-year plan, including regular maintenance and replacement of playground equipment, aggressive pursuit of funding opportunities, monitoring the Ohio River bank for signs of erosion and similar initiatives.

There was no comment from the public at the hearing, but town council members did offer some input that will be incorporated into the final plan. They called for more emphasis on handicapped accessibility, to ensure compliance with the Americans with Disabilities Act on all upcoming projects.

With that note added to the final draft, the public hearing on the park plan concluded. The town council later voted unanimously to pass a resolution to submit the final park plan for approval by the DNR upon its completion.

The second public hearing of the evening focused on the application for the utility planning grant, funded by the federal Community Development Block Grant program and administered by OCRA. The application is due by April 14, and Nathan Held of Indiana 15 Regional Planning Commission emphasized the need for the town to make an impression with its application.

There's a lot of money floating around right now, and the public sector across the nation is snapping at the chance to tackle long-standing issues and long-sought capital projects. Planning grants, which not only identify needs but provide valuable data to back up applications for other funding, are naturally in a state of high competition as well.

"We really need to make it the best application that we can," said Held. That means documenta-

tion. Any documented water wastewater issue, preferably with photographic evi-dence, could help Grandview's chances of securing funding. There are currently three letters in hand, detailing some of the needs in the community. Held noted a total of seven such letters can be submitted along with the grant, but extras are always handy as this allows grant writers to select the most compelling evidence for submission. If the total number of letters provided exceeds seven, that detail is also included in the application. The big thing Held asked council members to seek out over the next week or so, however, was photo documentation to go with

Pictures of flooded yards, damaged infrastructure, etc. could speak volumes. Held pointed out those officials in charge of scoring individual grant applications are very busy right now, and most have never been to Grandview or Spencer County. Every application might contain real needs, but it's easier to relate to a problem with photographic evidence to rely upon.

"Pictures are great," said Held. "They like to see pictures."

The propensity of the Ohio River to flood certainly weighs heavily on the towns water and wastewater system. If those needs are successfully sold to the scoring committee and a planning grant awarded, Grandview could benefit from further funding on a range of improvements. For example, mitigation efforts to prevent floodwaters from infiltrating the sewer system, replacing old water lines, a new water tower, etc.

The council unanimously approved a resolution to complete and submit an application for the maximum amount through the planning grant. This resolution included a commitment of \$10,000 on the part of the town for the local match requirement, should the grant be awarded. However, the town has ARP funding set aside to cover that \$10,000 match.

The council also:

 Will meet in special session Wednesday, April 6 at 5:30 p.m. at the town hall to discuss a contract with the full board of Finch-Newton Water.

 Discussed troublesome properties, including a number of fines sent out to owners.

 Voted to approve a bill adjustment for a resident erroneously charged for sewer use during a time when the meter should have been off. Town Manager Keith Nix noted this was due to a faulty valve that has since been fixed.

 Heard Councilman Dakota Risse say he has been keeping in touch with the Grandview Civic Association, with the goal of helping both bodies coordinate on projects, such as town-wide dangure and parades.

• Learned the Grandview Volunteer Fire Department will host a pancake breakfast from 7 to 10 a.m. April 16 for \$8 per person.

 Discussed seeking bids for new storage space for town equipment and supplies, including the town's road salt stockpile.

# **Public Hearing notes**

Doug Risse called the public hearing to order on March 21, 2022 at 5:00 pm. He then turned the hearing over to Cheri Taylor with Indiana 15 Regional Planning Commission.

Ms. Taylor made introductions and explained that Indiana 15 RPC had been contracted to develop a five-year Master Park Plan. The purpose of the park master plan is to plan for improvements over the next five years. The plan is not set in stone, it can be amended at any time. An Indiana Department of Natural Resources approved Five-Year Master Park Plan makes established park organizations eligible to apply for IDNR funding.

Ms. Taylor further explained that comments were received via online survey, phone calls and word of mouth. Yard signs, direct emails and signs at Town Hall promoted the online survey. A sign at the public library promoted the online survey and phone calls with comments and ideas.

The plan was developed with the help of the Town Manager from comments received. The yearly workplan was reviewed in detail for those present. A draft was sent to IDNR for review on January 13th. Ms. Taylor received comments back from IDNR which have been incorporated into the present draft handed out tonight. Comments received tonight until submitted will be incorporated into the final draft. The final plan is due to IDNR by April 15th.

Ms. Taylor then opened the floor to comments from those present.

Doug Risse commented that the draft incorporated the comments he had heard from those that had reached out to him during and before this process began.

Angie Fischer commented that everything she had brought to her had also been incorporated into the final plan. Others agreed with these comments.

Ms. Taylor asked if anything had been omitted from the draft that should be included or if anything needed to be changed before the final draft? Everyone agreed that the draft was complete and correct.

Doug Risse reminded those present that more emphasis should be placed on handicap accessibility to ensure compliance with the Americans with Disabilities Act on all upcoming projects. "We should strive to make all our parks accessible to everyone."

Ms. Taylor thanked the Park Authority for the opportunity to work on this project. In turn the Park Authority thanked Ms. Taylor and Indiana 15 RPC for their continued community partnership.



- Walkway from the ramp to the boat launch


# **Facilities Location Map**




# **Grandview City Park**




# **Old Mill Park**




# **Schroeder Park**

# **Appendix**

#### ORDINANCE NO. 2019-11-21-01

## AN ORDINANCE ABOLISHING THE PARKS AND RECREATION BOARD AND ESTABLISHING THE TOWN OF GRANDVIEW PARK AUTHORITY

WHEREAS, the Town Council of the Town of Grandview, Indiana (hereafter, "Town") operates and maintains various parks throughout the town;

WHEREAS, the town previously established a Town Parks and Recreation Board for the purpose of governing and overseeing the town parks;

WHEREAS, the legislative body for the town has discretion as to how the town parks are governed;

WHEREAS, the legislative body may establish a Park Authority for the purpose of managing all public parks that belong to the municipality;

WHEREAS, the legislative body may designate the Town to serve as the Park Authority;

NOW THEREFORE BE IT ORDAINED by the Town Council of the Town of Grandview, Indiana as follows:

- A. The Town of Grandview Parks and Recreation Board, organized under I.C. 36-10-3 and described in Chapter 1.22 of the Grandview, Indiana Codifications of Ordinances, shall be dissolved upon passage of this ordinance;
- Upon passage of this ordinance, the positions described as Parks and Recreation Board shall be eliminated;
- C. The Town of Grandview Town Council is hereby designated as the Park Authority, and charged with the management of all town parks [authority, I.C. 36-10-5-2 (b)(2)(C)];
- The Town of Grandview Town Council as the Park Authority, may adopt rules concerning the laying out, improvement, preservation, ornamentation, and management of the parks;
- E. The Park Authority may appoint a person to serve as Director of the Grandview Parks, and said Director shall have discretion to carry out day-to-day functions of scheduling events and seeking grants and ideas, subject to approval of the Park Authority;
- The Director of the Grandview Parks shall report regularly to the Grandview Park Authority when it meets as the Grandview Town Council;
- G. Maintenance, mowing and upkeep of Parks grounds and equipment shall be done in like manner as other Town properties by Town employees;

- H. The Rules and Regulations and Fees, set forth in Grandview, Indiana Codifications Chapter 1.22 are hereby reaffirmed as the current rules, regulations, and fees for the Grandview Parks;
- I. All books, papers, documents, and other property of the former Grandview Parks and Recreation Board shall be transferred to the Town of Grandview, and owned, held, and maintained as all other municipality owned property, subject to the governance of the Grandview Park Authority. These documents shall be kept and maintained at Grandview Town Hall by the Clerk-Treasurer.

This ordinance shall be in full force and effect from and after its promulgation according to law.
