

# CITY OF CANNELTON

## Municipal Code

A Codification of Relevant Ordinances of the City of Cannelton, Indiana.

ADOPTED 1996 by Ordinance No. 96-03

1. The "Cannelton, Indiana, Code of Ordinances" is hereby adopted as the municipal code for the City of Cannelton. (Ord. 96-03, S1, March 25, 1996)
2. The Council hereby states that the code is intended to be a restatement of the original ordinances or amendments as referenced in the code. In the event there is any discrepancy between the substantive language of the code and the ordinance or amendment, then the ordinance or amendment shall control. (Ord. 96-03, S2, March 25, 1996)
3. The code includes all relevant ordinances deemed appropriate for inclusion which were adopted on or prior to December 31, 1995, with the exception of Ordinance No. 96-02, which has been included in the code. (Ord. 96-03, S3, March 25, 1996)

## PREFACE

The Municipal Code of the City of Cannelton is adopted and published in order to comply with IC. 36-1-5-1 and in order that there be a more orderly and practical means whereby interested persons may refer to those ordinances which may have a direct and immediate impact on their rights and responsibilities.

The Code will be kept current by periodic supplementation and now contains ordinances provided by the City to Indiana 15 Regional Planning Commission through Ordinance 2016-14 excluding formal parts, and are re-arranged by general subject matter for purposes of this codification.
