## Chapter 7.02

### PARKING

#### Sections:

- 7.02.010 No parking zones designated**
- 7.02.020 Limited parking areas designated**
- 7.02.030 Penalties for violation**

**7.02.010 No parking zones designated.** It is unlawful for the stopping, standing, or parking of motor vehicles, horses, wagons or other vehicles on the curb line of any part of the following named streets in the area as herein designated:

- A. Within twenty-five (25) feet of the intersection of Main Street and 5<sup>th</sup> Street.
- B. On the east side of Main Street from the intersection of Main and 5<sup>th</sup> Streets to 142 feet north of the intersection.
- C. On the west side of Main Street, within 110 feet of 4<sup>th</sup> Street.
- D. On east Fifth Street (formerly known as Meridian Street) where it adjoins the English Elementary School grounds (stopping and waiting for loading and discharging passengers is permitted).
- E. Right side of Oak Hill Drive (Ord. 1996-09, Sept. 26, 1996)  
(Ord. 1997-05, S5.01.010, June 12, 1997) (Ord. Unnumbered, Jan. 15, 1934)

**7.02.020 Limited parking areas designated.** It shall be unlawful for the extended parking, stopping or blocking public roadways by heavy weight motor vehicles, trailers, machinery or equipment exceeding 26,000 GVW except for the loading or unloading of commerce items to businesses, residents or public entities on the following named streets for more than one (1) hour:

- A. Fifth Street from the intersection of Main Street east to the intersection of County Road number 213.
- B. Oak Hill Drive from the north intersection of Indiana Avenue to the south intersection of Indiana Avenue.
- C. Indiana Avenue from the intersection of State Highway 64, to the intersection of County Road number 213.

- D. Tulip Drive from the intersection of Indiana Avenue on the north side, to the intersection of Indiana Avenue on the south.
- E. Chestnut Drive east from the intersection of Indiana Avenue.
- F. Hickory Court south from the intersection of Chestnut Drive.
- G. Walnut Drive east from the intersection of Indiana Avenue.
- H. Strawberry Lane south from the intersection of State Highway 64. (Ord. 1997-05, S5.01.011, June 12, 1997)

**7.02.030 Penalties for violation.** Any person violating the provisions of this Chapter shall be fined a sum not to exceed twenty-five dollars (\$25). (Ord. 1997-05, S5.04.020, June 12, 1997)

## Chapter 7.04

### ONE-WAY STREETS

**7.04.010 Establishment of One-way streets.** The following One-way Street is established:

- A. Oak Hill Drive twenty five (25) feet south of the Crawford County Public Library entrance south to the intersection of Indiana Avenue. (Ord. 1997-05, S5.01.012, June 12, 1997)

**7.04.020 Penalties for violation.** Any person violating the provision of this ordinance shall be fined a sum not to exceed twenty-five dollars (\$25). (Ord. 1997-05, S5.01.020, June 12, 1997)

## Chapter 7.06

### SPEED LIMITS

#### Sections:

- 7.06.010**      **Speed limits established**
- 7.06.020**      **Penalties for violation**

**7.06.010 Speed limits established.** The following speed limits are established:

- A.      On Fifth Street 30 mph, except 300 feet south of the west entrance of English Elementary to 300 feet beyond the east entrance of English Elementary School, which shall be 20 mph.
- B.      30 mph Indiana Avenue south of SR 64 to the intersection of Fields Lane.
- C.      15 mph on Deerwood Drive.
- D.      15 mph on Strawberry Lane.
- E.      15 mph on Judicial Plaza Drive.
- F.      20 mph on Church Street.
- G.      20 mph on all other town streets with the exception of SR 64 and Main Street and any street which has the jurisdiction of the Indiana State Department of Transportation and which conflicts with IC 9-21-1-3 and IC 9-21-5-6. (Ord. 2003-06, S1, Nov. 11, 2003) (Ord. 1997-05, S5.04.010, June 12, 1997) (Ord. Unnumbered, Nov. 3, 1969)

**7.06.020 Penalties for violation.** Any person violating the provisions of this Chapter shall be fined a sum of twenty-five dollars (\$25). (Ord. 2003-06, S2, Nov. 11, 2003) (Ord. 1997-05, S5.04.020, June 12, 1997)

## Chapter 7.08

### STOP INTERSECTIONS

#### Sections:

#### **7.08.010 3-Way Stop.**

- A. Chestnut Drive in both easterly and westerly direction of travel at the intersection of South Hickory Court. All motorists will hereby stop at this established intersection before commencing in an eastern or western director of travel. (Ord. 2000-08, S1, June 8, 2000)

**7.08.050 Penalties for Violation.** Any person violating Ordinance 2000-08 shall be fined a sum not to exceed twenty-five dollars (\$25.00). (Ord. 2000-08, S2, June 8, 2000)

## Chapter 7.10

### SNOW EMERGENCY PLAN

#### Sections:

**7.10.010 Declaration of Snow Emergency.** The President of the Town Council by recommendation of the Town Manager or other department heads may declare a “Snow Emergency” for the Town of English. During this emergency no parking on town streets will be permitted. (Ord. 1999-02, S1, January 14, 1999)

**7.10.020 Street priorities.** The Town of English hereby designates the following emergency plan and priorities for the streets within the Town of English:

- A. First Priority-Major Streets
  - 1. East & West Fifth Street
  - 2. Court Ave. S from W Fifth Street

3. Indiana Avenue
4. West Church Street

B. Next Priority-Secondary Streets

1. All secondary streets. (Any street with vehicles parked along them can hinder the clearing process. Therefore any vehicles parked along these streets may not be cleared as adequately as needed. The Street Department may order the Town Marshal's to contact the owners to remove them or have them towed at the owners expense.)
2. Secondary streets will not be prioritized unless the Town has prior knowledge of illnesses to residents on such street. The workers will attend to these situations as expeditiously as humanly possible.
3. The Town of English will not be responsible for clearing private driveways or roadways unless immediate danger to life or property are eminent. It is the responsibility of residents to clear their driveway and snow from around their mail and paper boxes. (Ord. 1999-02, SII, Jan. 14, 1999)

## Chapter 7.20

### USE OF TOWN ROADS BY OFF-ROAD VEHICLES

**7.20.010 Definitions.** "Off-road vehicles" as defined in I.C. 14-1-3-1, et. seq. may use Town of English roads, inside the corporate limits of the Town of English. (Ord. 1987-4, S1, Nov. 4, 1986)

**7.20.020 Valid driver's license to operate an off-road vehicle.** No person shall operate an "off-road vehicle" as defined in I.C. 14-1-3-1, et. seq. without a valid motor vehicle driver's license. (Ord. 1987-4, S2, Nov. 4, 1986)

**7.20.030 Prohibited uses by Indiana Law.** No use otherwise prohibited by Indiana Law shall be permitted on Town of English Roads. (Ord. 1987-4, S3, Nov. 4, 1986)

**7.20.040 Off-road vehicles prohibited.** The Town of English Highway Superintendent shall be permitted to post certain Town of English roads for non-use of "off-road vehicles" by posting signs on said roads. (Ord. 1987-4, S4, Nov. 4, 1986)

**7.20.050 Subject to all other traffic rules.** All operators of "off-road vehicles" under the purview and proscriptions of this Ordinance shall be subject to all other Town of English Traffic ordinances, in addition to the rules of the road as set forth in Indiana Code Title IX and XIV. (Ord. 1987-4, S5, Nov. 4, 1986)

**7.20.060 Penalty for violation.** Anyone who violates this Ordinance by driving on a Town of English road marked "Prohibited to off-road vehicular traffic", or who is otherwise in violation of other Town of English ordinances for rules of the road, shall be fined in any amount not to exceed \$500.00. (Ord. 1987-4, S6, Nov. 4, 1986)
