Chapter 15.07

SPEED LIMITS

Sections:

- 15.07.010** **Maximum speed limits**
- 15.07.020** **Penalty for violation**

15.07.010 Maximum speed limits. No person shall drive or operate a motorized vehicle along, upon or across any public street, or roadway in the Town of Grandview, in excess of the maximum speed limit. The maximum speed limit is hereby established a twenty-five (25) miles per hour, except for State Road 66, which maximum speed is set by the State of Indiana. (Ord. 2002-5-07, S15.07.010, May 6, 2002)

15.07.020 Penalty for violation. Violations of this Chapter shall constitute a moving traffic offense. Whenever a police officer shall find that such offense has been committed, such officer may prepare in duplicate written notice to appear in court in conformity with I.C. 9-30-3-6, and the Indiana travel information and summons form shall be used for that purpose. The penalty for such violation shall be the penalty proscribed for a Class C infraction by I.C. 34-28-5-4. (Ord. 2002-5-07, S15.07.020, May 6, 2002)

STOP INTERSECTIONS

15.12.010 Stop Streets/Through Streets. The following intersections in the TOWN OF GRANDVIEW are hereby declared to be through streets and stop streets when signs are erected giving notice thereof to the drivers of vehicles as follows:

15.12.020 Stop intersections. The following streets shall be stop streets for vehicular traffic entering the intersection from the direction designated as follows:

15.12.030 Penalty for violation. Violations of this Chapter shall constitute a moving traffic offense. Whenever a police officer shall find that such an offense has been committed, such officer may prepare in duplicate written notice to appear in court in conformity with I.C. 9-30-3-6, and the Indiana traffic information and summons form shall be used for that purpose. The penalty for such violation shall be the penalty proscribed for a Class C infraction by I.C. 34-28-5-4. (Ord. 2002-5-08, S2, May 6, 2002) (Ord. unnumbered, Jan. 4, 1960)

Chapter 15.24

PARKING

Sections:

15.24.010 Parking zones.

- (1) Main Street:
 - A. Using Fifth Street as the dividing line, parking on either side of Main Street South of Fifth Street (toward the river) shall be posted with thirty (30) minute restriction signs between 8:00 A.M. and 4:00 P.M. (Ord. 2001-09-19B, S1, Sept. 19, 2001)
 - B. Using Fifth Street as the dividing line, parking on either side of Main Street (SR 66) toward the Civic Center (North) shall be prohibited. "No Parking" signs will be posted. (Ord. 2001-09-19B, S2, Sept. 19, 2001)

General Comments; It is the Town Council's understanding that all signage and maintenance of signage to include placement and replacement will be the responsibility of INDOT. (Ord. 2001-09-19B, Sept. 19, 2001)

- (2) Fourth Street: Parking is limited on Fourth Street between Locust Street and Main Street to thirty (30) minutes between the hours of 8:00 a.m. and 6:00 p.m. Monday through Friday. (Ord. 2004-8-2, Aug. 3, 2004) (Res. 1962-2, pt. S1, Dec. 17, 1962)

15.24.020 Penalty for violation. Unless other penalty is expressly provided by law, every person convicted of a violation of any provision of this Ordinance shall be punished by a fine of not more than Ten (\$10.00) Dollars for each and every violation. (Res. 1962-2, pt. S1, Dec. 17, 1962) (Res. unnumbered, Oct. 2, 1961)

Chapter 15.28

PERMITTING PROCEDURES FOR OVERSIZED VEHICLES ON TOWN STREETS AND ALLEYS AND DAMAGES FOR NON-COMPLIANCE

15.28.010 Provisions. That upon passage of this ordinance, the provisions of this ordinance shall not relieve any person from the duty to observe other and more restrictive provisions prohibiting or limiting the stopping, standing or parking of vehicles in specified places or at specified times.

15.28.020 Exemptions. Nothing contained in this ordinance shall apply to any town, state, utility, school bus, or publicly owned vehicle. The defined business district for the town of Grandview shall be exempt from the provision of this Ordinance.

15.28.030 Written permission. No person shall park any wheeled device, or motor or non-motorized vehicle that is more than 21 feet long, more than eight feet wide or more than nine feet high on any street or alley within the jurisdiction of the Town of Grandview without the written permission of the Town Council. This shall include combination vehicles and all other vehicles with three (3) axles.

15.28.040 Issuance of Permit. The Town Council is authorized to issue permits for parking of vehicles as specified in Section 15.28.030 of this chapter which would otherwise be in violation of this ordinance only if the Board determines the parking will not present a hazard or create an obstruction of traffic.

15.28.050 Repair expenses. Any owner of any vehicle as described in Section 15.28.030 of this chapter shall be personally liable for any and all expense or cost of repairs to any street, curb, street signs, or poles.

15.28.060 Notice. Any law enforcement of the town, county or state, or anyone designated by the Town Council of the town of Grandview, Indiana, shall have the authority to notify owners or operators of vehicles as defined in Section 15.28.0130 of this chapter. Said Notice of Violation of the ordinance is considered served if left on the windshield of the vehicle. Repeat violators are subject to having said vehicle removed and impounded with the cost of removal being at the owner or operator's expense.

15.28.070 Fine. There is hereby imposed a fine of fifty (\$50.00) dollars for each violation, payable to the Clerk-Treasurer on behalf of Town Council. (Ord. 2016-4-7-1, May 16, 2016)

Chapter 15.44

BICYCLES

Sections:

15.44.010 Unlawful to ride upon sidewalks. Be it ordained by the Board of Trustees of the Town of Grandview, Spencer County, Indiana, that it shall be unlawful for any person to ride a bicycle on any sidewalk in said Town. (Ord. No. 9, S1, No date)

15.44.050 Unlawful to ride at night without lighted lamp. Be it ordained by the Board of Trustees of the Town of Grandview, Spencer County, Indiana that the riding of bicycles at night on any of the streets of said Town of Grandview without having thereon a lighted lamp or lantern is hereby prohibited. (Ord. unnumbered, May 3, 1899) (Ord. No. 15, S1, No Date)

15.44.060 Penalty for violation. Any person or persons who violate this Chapter shall be deemed guilty of misdemeanor and do hereby place a penalty of one dollar (\$1.00) fine for each and every violation. (Ord. unnumbered, May 3, 1899) (Ord. No. 15, S2, No date) (Ord. No. 9, S2, No date)
