#### **FISHING**

# **12.02.010** Fishing

**12.02.010 Fishing.** Fishing shall be permitted upon the municipally owned lakes of the Town by any person holding a valid fishing license as issued and required by the Department of Natural Resources of the State of Indiana; provided, however, that it shall be unlawful for any person to fish in those areas of the municipally owned lakes of the Town which are specifically designated for swimming. ## **SWIMMING**

# **12.04.010** Swimming

**12.04.010 Swimming.** It shall be unlawful for any person to swim or wade in the waters of any of the municipally owned lakes of the Town for recreational purposes, except in those areas specifically designated for swimming and only during such time as a lifeguard hired and authorized by the Town is on duty. **12.06.010 Boating regulations.** It shall be unlawful to operate any boat upon any of the municipally owned lakes of the Town of Holland unless the owner of such boat has first obtained a permit for such purposes from the Clerk-Treasurer of the Town of Holland or his duly appointed agent. The permit shall be an annual permit effective from the date of issuance to the same date of the succeeding year. The cost of the permit shall be in the amount of Ten Dollars (\$10.00) for bona fide customers of the Holland Municipal Waterworks system, and Fifteen Dollars (\$15.00) for all other persons. A permit must be obtained for each and every boat to be operated upon any of the municipally owned lakes of the Town of Holland. **12.06.020 Types of boats permitted.** The following types of boats, and no others, will be permitted to be operated upon the municipally owned lakes of the Town of Holland if an annual permit has been obtained: conventional types of row boats, paddle boats, canoes, sail boats and boats powered by electric trolling motors. The operation of boats powered by gasoline or other combustion type engines is hereby expressly prohibited. (Ord. 4-90, S2, 1990) (Ord. 5-86, S2, 1986) (Ord. 23-77, S2, 1977)

**12.06.030 Safety devices.** All boats operated upon any of the municipally owned lakes of the Town of Holland must be equipped for safe operation, and shall be equipped with oars or paddles and with a Coast Guard approved type of life preserver for each passenger, which shall at all times be in place and available to each passenger in the boat when such boat is being used and operated upon the waters of any of the municipally owned lakes of said Town. Any person under the age of twelve (12) years shall wear a vest-type Coast Guard approved life preserver while a passenger in a boat on any of said municipally owned lakes. **12.06.040 Minimum age.** It shall be unlawful for any boat to be operated upon any of the municipally owned lakes of the Town of Holland unless at least one (1) passenger is fifteen (15) years of age or older. (Ord. 4-90, S4, 1990) (Ord. 5-86, S4, 1986) (Ord. 23-77, S4, 1977)

**12.06.050 Operation of boats.** Any person operating a boat shall operate the same in a careful manner, having due regards for the rights, safety and property of others. No person shall operate any boat which is loaded with passengers or cargo beyond the safe carrying capacity and condition of said boat. **12.06.060 Penalty for violation.** Any violation of this Chapter 12.06 shall be penalized by a Twenty-five dollar (\$25.00) fine. (Ord. 12.06, June 7, 2000)

**12.08.010 Pollution.** It shall be unlawful for any person to throw, drop or deposit into any of the municipally owned lakes any trash, debris or discharge any polluting liquid or solid into the waters of said lakes. **12.12.010 Alcoholic Beverages Prohibited.** It shall be a violation for any person to have in his possession or consume any alcoholic beverages while a passenger or operator of a boat upon any of the municipally owned lakes of the Town. ## **12.14.010** Penalty

**12.14.010 Penalty.** Any person, corporation or organization who is found to have violated any provision of this Title shall be subject to the payment of a penalty of not less than One Dollar (\$1.00) nor more than Twenty-Five Dollars (\$25.00) for each violation. Every day, or part of a day, that a violation is committed or continues in existence is a separate violation for which penalties may be imposed.
