## Chapter 6.08

### DISORDERLY CONDUCT

**6.08.005 Playing ball upon streets and alleys.** It shall be unlawful for any person or persons to enter into, or engage in any game or activity which requires the batting of a ball, on the streets or alleys of the incorporated Town of Leavenworth, except as herein provided. (Ord. unnumbered, S1, Mar. 5, 1925) (Ord. Series 1914, Feb. 13, 1914) (Ord. Series 1914, S1, S2, Feb. 5, 1914)

- (1) It shall be permissible to enter into, or engage in such games or activities wherein the ball is tossed but not batted, provided the game is not played on Nelson Street or State Road No. 62, or on any intersecting street or alley within one square adjacent to Nelson Street or State Road No. 62. (Ord. unnumbered, May 17, 1933) (Ord. unnumbered, S2, Mar. 5, 1925)
- (2) Should a ball or similar object enter the property of private persons so that trespass on the private property to retrieve such balls, or similar objects is needed, this person shall be guilty of a misdemeanor and upon conviction shall be fined not less than \$1.00 nor more than \$10.00 for each separate violation. (Ord. 123, May 3, 1939)
- (3) It shall be the duty of the Marshal to arrest those who violate the provisions of this Ordinance, and upon conviction they shall be fined not less than \$1.00 nor more than \$10.00 for each separate violation. (Ord. 123, May 3, 1939) (Ord. unnumbered, S3, Mar. 5, 1925)
- (4) Fines collected by provisions of this Ordinance shall be paid to the credit of the general fund of the said Town. (Ord. unnumbered, S4, Mar. 5, 1925)

**6.08.006 Throwing snowballs, rocks and pebbles upon the streets and alleys.** It shall be unlawful for any person or persons to throw snowballs, rocks, and pebbles, upon the public streets or alleys within the incorporated Town of

Leavenworth, Indiana or in any place where said Town of Leavenworth, Indiana has jurisdiction thereover. Any person or persons found guilty of violating this Ordinance shall be fined in any sum not exceeding ten dollars. (Ord. unnumbered, S1, 2, May 17, 1933)

**6.08.010 Fighting upon streets and alleys.** Be it ordained by the Board of Trustees of the incorporated Town of Leavenworth, Indiana, that, it shall be unlawful for any person or persons to engage in wrestling or scuffling upon the public streets and alleys, within the incorporated Town of Leavenworth, Indiana, or any place where said Town of Leavenworth, has jurisdiction thereover. Any person or persons found guilty of violating this Section shall be fined in any sum, not exceeding (\$10.00) Ten Dollars. (Ord. Series 1914, Feb. 13, 1914) (Ord. Series 1914, S1, S2, Feb. 5, 1914)

**6.08.020 Prohibiting shooting.** Shooting bean shooters, air guns, flobert rifles, upon the streets and alleys of the Town of Leavenworth is prohibited. Any person or persons found guilty of violating this Section shall be fined in any sum, not exceeding (\$10.00) Ten Dollars. (Ord. Series 1914, S2, Feb. 5, 1914)

**6.08.030 Anti-spitting.** Spitting upon the floor, walls, side, stairways, or platform of any railroad, steam, electric, elevated, street subway, station or car, or elevated car, or elevator car, or any public or private conveyance, or of any public or private building, hall, theatre, church, school, hotel, boarding house, factory, workshop, or other places of employment, or any house, tenement house, market or upon any sidewalk, in any public or private place, or premises, is hereby prohibited. Any person violating any provisions of this Ordinance shall be fined no less than one dollar nor more than five dollars for each separate offense. (Ord. 25, Series 1914, S1, S2, Sept. 15, 1914)

**6.08.040 Roller-skating.** That on and after May 5, 1939, whoever shall roller skate upon the sidewalks of the Town of Leavenworth shall be guilty of a misdemeanor and upon conviction shall be fined not less than \$1.00 nor more than \$10.00 for each separate violation. (Ord. 123, May 3, 1939)

**6.12.010 Discharge of firearms.** It shall be unlawful for any person or persons to discharge, fire, shoot or otherwise make use of any firearms or other type rifles, gas pistols, revolvers, shot guns or pistols within the corporate limits of said Town unless by special permit or some official action of authorized officers of the law. (Ord. 155, Jan. 3, 1957)

**6.12.020 Carrying weapons.** It is further ordained that it shall be unlawful for any person or persons to carry any such weapons or instrument capable of doing injury to life, limb, property or wild life loaded or concealed within the corporate limits of said Town. (Ord. 155, Jan. 3, 1957)

**6.12.030 Penalty for violation.** The penalty for the violation of this Ordinance and Town law shall be fined not less then Ten Dollars nor more than Twenty-Five Dollars for each and every offense. (Ord. 155, Jan. 3, 1957)

**6.12.040 Reporting violators.** It shall be the duty of any citizen of said Town to report to the proper authorities anyone who knowingly or willingly violates this said Ordinance that any who are deemed guilty can be prosecuted accordingly. (Ord. 155, Jan. 3, 1957)

## Chapter 6.21

### OPERATION OF MOTOR BOATS WHILE THE OHIO RIVER IS AT FLOOD STAGE

**6.21.010 Unlawful to operate boats on overflowing waters.** Be it ordained by the board of Trustees of the incorporated Town of Leavenworth, Indiana, that it shall be unlawful for any person or persons to operate its machinery, or propel by mechanical means any craft, skiff, boat, barge or crafts of any description whatever on overflowing waters within the limits of the streets and alleys and other public places of the incorporated Town of Leavenworth, Indiana, or in any place where said board has jurisdiction. Or further be it ordained that it shall be unlawful for any person to operate or attempt to operate the machinery of any craft as aforesaid on overflowing waters within the limits of the streets and alleys of the incorporated Town of Leavenworth, Indiana, or in any place where the said board has jurisdiction, when the machinery herein referred to, produces an exhaustive noise or explosion. (Ord. Series 1914, S1, Apr. 3, 1914)

**6.21.020 Operator.** Be it further ordained that, when said boat contains two or more persons or is at such a distance from observers, as to make the identification of the operator doubtful, or when such machinery is operating as aforesaid without any person in charge. Then the owner of the said boat shall be declared the operator and shall be found guilty under the provisions of this Ordinance. (Ord. Series 1914, S2, Apr. 3, 1914)

**6.21.030 Seizure of motor craft.** Be it further ordained that if under Section 6.21.020 of this Chapter, there remains a doubt as to the lawful owner of said boat, skiff, raft, barge or other craft, then the Marshal shall be empowered to seize the boat at any subsequent time, when said boat is found within the corporate limits of said Town of Leavenworth, Indiana, or in any place where the said trustees of said Town have jurisdiction as defined by the laws of the State of Indiana, and may hold such craft, pending the identification of the legal owner. (Ord. Series 1914, S3, Apr. 3, 1914)

**6.21.040 Recovery of costs.** Be it further ordained that the Marshal be allowed as costs, any sum, as may be necessary for the proper care of such boat, and such costs must be paid by the person found guilty under Sections 6.21.010, 6.21.020 and 6.21.030 of this Chapter. (Ord. Series 1914, S4, Apr. 3, 1914)

**6.21.050 Penalty for violation.** Be it further ordained that any person found violating the sections of this Chapter, shall be tried in any court of justice, and if found guilty of violating this Ordinance, shall be fined in any sum, not exceeding ten dollars. (Ord. Series 1914, S5, Apr. 3, 1914)
