Chapter 4.08

PEDDLERS

4.08.010 License required. It shall be unlawful for any person, firm or corporation to hawk or peddle meat, fruit, vegetables, melons, produce, dairy products, or any other goods, wares or merchandise anywhere within the city limits of the Town of Marengo, Indiana, without having first obtained as hereinafter provided a license to do so. (Ord. unnumbered, Dec. 30, 1953) (Ord. unnumbered, pt. Art. 1, Apr. 3, 1950)

4.08.020 Definitions. For the purpose of this ordinance (chapter) the words “peddle” and “hawk” are defined as meaning to sell, or to offer for sale, any personal property directly to a user or consumer, either by one going from house to house for the purpose or selling and delivering such property, or for the purpose of taking orders for the future delivery thereof, or by one selling and delivering such property from a vehicle, pack or other container in any street, alley, public square or other public place in said city. (Ord. unnumbered, Dec. 30, 1953)

4.08.030 Enforcement / Penalty for violation. The Marshal of the Town of Marengo, Indiana, is hereby appointed a license inspector, and any licensee hereunder shall exhibit his license to said Marshal on request to do so. Any person violating any provisions of this ordinance (chapter) shall forfeit and pay to the Town of Marengo the sum of \$25.00, and in case of a license hereunder shall, in, addition thereto, forfeit such license. (Ord. unnumbered, Dec. 30, 1953) (Ord. unnumbered, pt. Art. 2, Apr. 3, 1950)

4.08.040 License fee. The license fee shall be as follows:

Peddler or hawker, \$1.00 for each vehicle used by the application in such business for an employee, servant, agent or helper of a licensed peddler or hawker, or of a peddler or hawker exempt from obtaining such a license, or permit as aforesaid, the following fees:

\$10.00 per day;

\$25.00 for three months;

\$40.00 for six months;

\$60.00 for one year. (Ord. unnumbered, Dec. 30, 1953) (Ord. unnumbered, pt. Art. 1, Apr. 3, 1950)

LIQUOR RETAILER'S PERMIT

4.12.010 Consenting that the State of Indiana may issue liquor retailer's permit in town

4.12.010 Consenting that the State of Indiana may issue liquor retailer's permit in town. Be it ordained by the Board of Trustees of the town of Marengo, Indiana, that the consent of said town be and the same is hereby given and granted unto the proper legal authorities of the State of Indiana, to issue liquor retailer's permits for the sale of alcoholic, spirituous beverages to applicants otherwise duly qualified to premises within said town, all agreeable to the provisions of section eighteen (18) of an Act of the General Assembly of the State of Indiana, entitled "AN ACT concerning alcoholic beverages, liquids and substances, and to promote temperance, repealing laws and parts of laws and declaring an emergency," approved March 11, 1935. Chapter 4.33

POOL TABLES / GAME TABLES

4.33.010 License required. Be it ordained by the Board of Trustees of the Incorporated Town of Marengo, Indiana, that any person, firm or corporation operating, exposing for operation or keeping in any place of business to be operated or played upon, any pool table, miniature pool table or any small size table, upon which any pool game is played, regardless of the number of balls used in playing upon the same; or any ping-pong table or any other table or device played for amusement or game of chance; shall before the keeping or operation of any such table or devices pay to the Treasurer of said Town a license fee in such amount as fixed in Section 4.33.020 of this chapter. (Ord. unnumbered, S1, June 6, 1938)

4.33.020 License fee. The license fee for the use of any table, game or device as described in Section 4.33.010 of this Chapter shall be in the sum of Fifty (\$50) Dollars per year for each of such tables, games or devices, payable to the Clerk-Treasurer on or before January 31st of each year. In the event any game or device as described herein is installed after January 31st of any year, then, the license fee shall be Five (\$5) Dollars per month multiplied by the number of months remaining until January 31st of the following year. Upon payment of such license fee as herein provided, the Town Treasurer shall issue such license which shall be valid from the date of payment for the same until January 31st of the following year, and said license shall be posted in a conspicuous place in the place of business where such table, game or device is used. 4.33.030 Penalty for violation. It is further ordained by said Board of Trustees that any person, firm or corporation so operating any such table, game, or device as described in Section 4.33.010 of this Chapter without first securing said license shall be in violation of this Ordinance (Chapter) and, upon conviction thereof, shall be fined a sum not to exceed Five Hundred (\$500) Dollars with the failure to secure a license for each device constituting a separate offense. PUBLIC DANCES AND DANCE HALLS

4.35.010 Permit required. No person, firm or corporation shall operate a public dance in the Town of Marengo without first securing from the Clerk-Treasurer of said Town a permit for said operation and paying therefor the sum of Twenty Five Dollars (\$25.00) for each public dance so held. (Ord. 214, S1, No date)

4.35.020 License form. Said license shall be applied for on forms prescribed by the Town of Marengo and which is as follows, and shall be available to the applicant at the office of the Clerk-Treasurer, and must be secured at least three (3) days prior to the operation of said dance and said license shall be exhibited publicly in the establishment in which said dance is held so that the same may be readily visible to any peace officer inspecting said premises. 4.35.030 Hours of operation. Said license shall permit the holder thereof to operate a dance in the Town of Marengo between the hours of 7:00 p.m. Central Daylight Savings Time and the hour of 12:00 a.m. Central Daylight Savings Time. (Ord. 214, S3, No date)

4.35.040 Penalty for violation. The violation of said Ordinance shall be a criminal offense and any person violating the same, for the first offense shall be fined in the sum of not less than Ten Dollars (\$10.00) nor more than Twenty Five Dollars (\$25.00) and for each

subsequent offense, the violator shall be fined in the sum of not less than Twenty Five Dollars (\$25.00) nor more than Fifty Dollars (\$50.00). (Ord. 214, S4, No date)
