Chapter 7.03

DOGS

7.03.010 Stray dogs. It is unlawful for any person owning or harboring any dog or dogs to allow his/her dog or dogs to stray beyond his/her premises, unless said dog or dogs are under the reasonable control of some person. Reasonable control includes, but is not limited to, having said dog or dogs on a leash, or installing some manner of electrical fence that is intended to keep said dog or dogs on the premises.

7.03.020 Penalty for violation. Any person that is cited for violation of the above ordinance will be subject to the following series of fines:

First Offense:	\$20.00 fine
Second Offense:	\$35.00 fine
Third Offense:	\$50.00 fine
Subsequent offenses:	\$100.00 fine

7.03.030 Appeal process. Any person that wishes to appeal the fine may do so in writing within fifteen (15) days from the date the fine was levied. The appeal should be directed to the Town Board of Marengo and will be decided by the Town Board at the next regularly scheduled monthly board meeting.

7.03.040 Payment of fine. Violators shall make their fine payable to the Town of Marengo by certified check or cash and paying said fine by mail to P.O. Box 206, Marengo, IN 47140 or by delivery to the Marengo Town Hall. (Ord. 081108-B, Aug. 11, 2008)

KEEPING OF LIVESTOCK

7.06.010 Keeping of livestock prohibited. It shall be unlawful for any person, organization, corporation or group to board, raise, maintain, breed, stable or otherwise keep or allow to be kept, cattle, horses, hogs, goats, chickens or any other livestock on any property lying with-in the Town Limits of Marengo. (Ord. unnumbered, 1992) (Ord. unnumbered, Sept. 5, 1978)

7.06.020 Livestock upon sidewalks prohibited. It shall be unlawful to ride, lead, or drive any horse, cattle, hog, goat or other farm livestock over or upon the sidewalks within the incorporated limits of the Town. (Ord. unnumbered, 1992)

7.06.030 Penalty for violation. Any person who violates the provision of this chapter may be fined a sum of not less than Twenty Five (\$25) Dollars nor more than Fifty (\$50) Dollars. Each day of violation after original notice by an authorized representative of the Council shall constitute a separate offense. (Ord. unnumbered, 1992) (Ord. unnumbered, Sept. 5, 1978)
