Chapter 4.08

PEDDLERS

Sections:

- 4.08.010 Permit required**
- 4.08.020 Definition of peddler**

4.08.010 Permit required. To prohibit any person or persons from peddling merchandise of any kind, meats, vegetables, fruits, or patent medicines inside the corporation without first securing from the clerk of the town a license or permit, in writing, and paying for same the sum of \$1.00. Such license or permit being good for the day issued only, and is not transferable and must be carried by the person or persons while peddling inside the corporation. (Ord. 19, Apr. 14, 1925)

4.08.020 Definition of peddler. The word peddlers in this ordinance shall apply to persons or person who bring and sell at retail the above named articles. But does not apply to Farmers or Manufacturers who are producers of same. Any one violating this ordinance shall be fined not less than \$5.00 or more than \$25.00. (Ord. 19, Apr. 14, 1925)

Chapter 4.23

POOL ROOMS

Sections:

4.23.010 Tax. To tax all pool rooms \$10.00 per year for each table used. Same to be paid on July 1, of each year. Rooms starting after July 1st of any year will be charged from the time they open to the next July 1st at the rate of \$10.00 per year. (Ord. 10, pt. S1, July 10, 1924)

4.23.020 Failure to pay. Any one who fails to pay on or before July 1st of each year or at the beginning of business, shall be fined not less than one dollar or more than five dollars a day for each table. (Ord. 10, pt. S1, July 10, 1924)

Chapter 4.26

DANCES

Sections:

4.26.010 License required. Be it ordained by the Board of Trustees of the Incorporated Town of Spurgeon, Pike County, Indiana, that after the legal adoption of this Ordinance, no person, Partnership, Corporation, Proprietor or Sponsor of any public dance, held within the Corporate limits of said Incorporated Town of Spurgeon, Pike County, Indiana, which public dance is held for hire or payment, shall have the legal right to sponsor, inaugurate, hold, maintain or carry on any such public dance within said Corporate limits of said Town, when held for hire or payment or admission fees, unless said person, Partnership, Corporation, Proprietor or Sponsor of said public dance so held for hire or payment or admission fees, shall first obtain from the Town Treasurer of said Incorporated Town of Spurgeon, Pike County, Indiana, a written license, certifying that said person, Partnership, Corporation, Proprietor or Sponsor of said public dance to be held for hire, or payment or admission fees, has obtained from said Town of Spurgeon, a license empowering and permitting the holding of said public dance. (Ord. 120, paragraph 1, July 10, 1933)

4.26.020 License fee. The license fee to be charged by said Town of Spurgeon, Pike County, Indiana to any person, Partnership, Corporation, Proprietor or Sponsor of any public dance so obtaining such license, shall be the sum of \$2.50 for each and every said public dance so held, carried on, maintained, conducted or sponsored by said person, Partnership, Corporation, Proprietor or Sponsor thereof. (Ord. 120, paragraph 2, July 10, 1933)

4.26.030 Penalty for violation. Any person, Partnership, Corporation, Proprietor or Sponsor of any such public dance who shall violate this Ordinance shall be fined in any sum not less than \$1.00, nor more than \$20.00 for each violation of said Ordinance; and each public dance held without first obtaining a legal license provided in this Ordinance, for the holding thereof, shall constitute a separate and distinct offense. (Ord. 120, paragraph 3, July 10, 1933)

Chapter 4.33

MAXEY'S PLACE

Sections:

4.33.010 Closing time/alcohol sales

4.33.010 Closing time/alcohol sales. Be it ordained by the Board of Trustees of the Incorporated Town of Spurgeon, Pike County, Indiana that this Ordinance shall be in full force and effect after the same shall have been displaced in Maxey's Place.

- (1) That this place shall close at 1:00 A.M. every day.
- (2) That this place shall sell no beer until 12:00 A.M. on Sunday morning.

This being written before said proprietor at his request. (Ord. 140, S1 & 2, Oct. 8, 1934)
