Minutes of the April 25, 2023 Full Board Meeting of the Indiana 15 Regional Planning Commission

CALL TO ORDER

Chair Paul Lorey welcomed the Full Board members and called the meeting to order at 7:00 pm.

ROLL CALL

Secretary Balaji Kashyab performed roll call; twenty-four members were present. Nathan Held and Cheri Taylor of the Commission and Craig McGowan with USDA were also in attendance. The Board recited the Pledge of Allegiance.

Craig McGowan - United States Department of Agriculture

Craig McGowan works with the US Department of Agriculture Rural Development. Craig manages the Jasper office and two other offices in southern Indiana. Rural Development deals a lot in housing, infrastructure (water/wastewater), business lending, electrical, and broadband. Craig works in community facilities (quality of place) projects and infrastructure (water/sewer).

Craig first discussed sustainability in water and wastewater issues. Bidding costs have increased. There is an index looking at energy consumption over a 20-year average. Energy consumption goes up about 4.5% per year. That includes fuel, oil, electricity, and natural gas. In April 2021 energy increased by almost 20%. This is why some utility budgets run out. There has been an increase in solar panels and renewable energy. Rural Development is looking into renewable energy for water and wastewater systems to help mitigate the cost in energy. Rural Development would like to use a Redevelopment Commissions to do General Obligation (GO) Bonds. If that is not an option for communities then they can do a redevelopment lease back. Redevelopment would get a loan for solar or energy storage to put in at your facility. It can be a loan up to 20-years. The reason to do a GO Bond or lease back is so there is no impact to your user rates. In the Inflation Reduction Act solar panels can be purchased with a 30-60% cash back rebate.

Another program is the Renewable Energy for America Program (REAP). This is renewable energy for small business and agriculture producers. The Inflation Reduction Act added grant of up to 60% of the project cost. Some uses for this program are installing geothermal, hydropower or solar panels for agriculture production and small businesses.

Another program Rural Development has seen a great need for is housing. The State has a residential TIF that can be used through the state. Rural Development can use the residential TIF to bond to develop the infrastructure for residential housing areas. This loan will help contractors put in the infrastructure of the housing plots. One thing Rural Development doesn't want to see is a community building more homes than they can pay back. Rural Development also wants communities to use 10% for housing rehabilitation. There is no prepayment penalty for this loan. Rural Development advises to add the loan cost into the price of the home to cover what is owed back to the State. To get started with this program communities need to conduct a housing study.

A short discussion was held after Craig's presentation.

AGENDA: ADDITIONAL BUSINESS

Chair Paul Lorey asked for any additions to the agenda. None were presented.

TREASURER'S REPORT

Treasurer Beverly Schulthise gave the Treasurer's Report. As of April 18th receipts were \$2,500.00 and disbursements were \$14,947.16. Since the report was printed, additional receipts were \$500.00 and disbursements were \$31,582.56. The actual total cash balance is \$760,235.24. The total aging schedule was \$50,176.46. There is one 12-month CD totaling \$250,000.00 and \$400,000.00 investment in TrustINdiana. The restricted savings has a balance of \$8,502.21. Bill Byrd made a motion to approve the Treasurer's Report pending audit, seconded by Mike Haverstock and motion carried.

DIRECTOR'S REPORT

Chair Paul Lorey turned the meeting over to Nathan Held for the Director's Report as follows:

- Nathan invited the Board to refer to the Project Status Reports for a more detailed look at current projects of the Commission.
- The INDOT 2023-2024 SURP contract has been received for signatures. Counts will be conducted in Dubois County.
- We are waiting to hear back on a Brownfields Assessment grant through EPA in the next couple of months.
- OCRA proposals are due by Friday. Five projects will be submitted. Commission staff are working hard to get these submitted on time.
- The City of Jasper was awarded a \$1.1 million EDA grant for back up water supply. Leah Hawkins is working
 with the Perry County Port Authority on a potential EDA project. There has been discussion on other potential
 projects to be funded through EDA.
- The City of Tell City is seeking a Land and Water Conservation Grant Fund through DNR. Jessica Condra and Cheri Taylor are working together on this project.
- Cheri Taylor and Lindsey Hoffman are working on a park plan for the City of Petersburg.
- Jessica Condra, our new Project Assistant, has jumped right in and seems to be a good addition to the team. Jessica has put in a lot of effort to become familiar with the Commission and jumping into projects.
